## ADVICE ON NOMINATING

- Nominations may be submitted by groups (e.g. committees, associations etc.) or individuals using this nomination form.
- Self-nomination by individuals or groups will not be accepted (including nominations from members/office-bearers for their own club - in these cases a club may choose to collaborate with another community organisation to submit applications on behalf of one another).
- These awards place emphasis on what the person/group has done for the community in a voluntary capacity, rather than as part of normal duties in a paid occupation.
- All areas on this form must be completed to enable fair consideration to all nominations.
- Please give accurate details of the person's/group's involvements i.e. state roles performed by the nominee, indicate their personal degree of involvement and outline how their leadership benefited the community.
- It is important to provide *specific* examples of how the nominee's contributions have been outstanding.

## ELIGIBILITY CRITERIA

Council, through its Australia Day Committee, will give consideration to the eligibility of individuals and groups for recognition against the criteria below:

- Individual nominees must be 27 years or older to be considered for Citizen of the Year and Senior Citizen of the Year
- Individual nominees must be under 27 years to be considered for Young Citizen of the Year
- Ages are as at 26 January in the awards year
- Nominees must be Australian citizens and have lived in the Derwent Valley municipality when this application is written
- Nominations must be received on official nomination application and prior to the close of nominations
- Self-nominations will not be accepted
- Unsuccessful nominees may be re-nominated in subsequent years
- Nominations may be held over for a period of 2 years at the discretion of the Australia Day Committee
- A person or group may not receive a second award in the same award category
